The revised HRA will be implemented with immediate effect, and arrears for the period from July 2024 to February 2025 (8 months) will be disbursed along with the salary for March 2025.

विषय: Enhancement in the rates of various Allowances on account of revision of rates of Dearness Allowance-reg.

Ministry of Finance, Department of Expenditure, Government of India, New Delhi had issued two separate Office Memorandums (OMs) vide number: (i) 2/5/2017-E.II(B) dated 07.07.2017 regarding Implementation of recommendations of the 7th Central Pay Commission relating to grant of House Rent Allowance (HRA) to Central Government Employees; and (ii) No. 19030/1/2017-E.IV dated 13.07.2017 regarding Travelling Allowance Rules- Implementation of recommendations of the 7th Central Pay Commission.

- In the above said OM dated 07.07.2017, it is clarified that- the rates of HRA will be revised to 27%, 18% & 9% for X, Y & Z class cities respectively when Dearness Allowance (DA) crosses 25% and further revised to 30%, 20% & 10% when DA crosses 50%. Further, in Annexure of above mentioned OM dated 13.07.2017 at point 'E (ii) to E(iv)-Daily Allowance on Tour', it is clarified that- the ceiling for reimbursement of Hotel/Travelling/Food Charges will furher rise by 25 percent whenever DA increases by 50 percent.
- It is stated to comply with OM No. 2/5/2017-E.II(B) dated 07.07.2017; and OM No. 19030/1/2017-E.IV dated 13.07.2017 of Department of Expenditure, Ministry of Finance, Government of India to revise rates of such allowances in accordance with enhanced rate of DA. Further, no separate order is required to be issued in this regard.
